up and tearing down as well as running the booths and games.



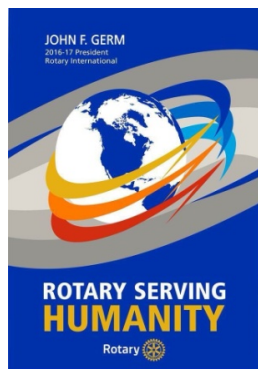

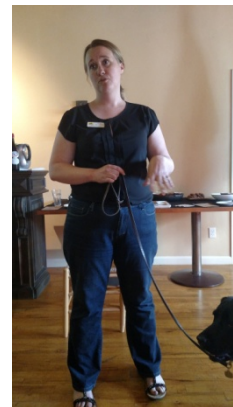

Angie Escudero. Development Associate and instructor for Canine Companions in Santa Rosa since 1975. They enhance the quality of life of people with disabilities by providing highly trained assistance dogs and ongoing support to ensure quality partnerships.



Angie has completed the three year apprenticeship program in 2007 and

became a full instructor. For the next six years she has trained and matched dogs and people with disabilities and taught the people how to use these highly skilled assistance dogs. She is the development associate for the Northwest Region of Canine Companions.

They have over 3,000 volunteers in six training centers. They provide dog assistants for hearing impaired, MS, MDS, vets with PTS. There are 14 puppies being trained in a prison setting. They mostly use labs, golden retrievers, and shepherds. The dogs learn over 40 commands to help the disabled with their daily lives.
